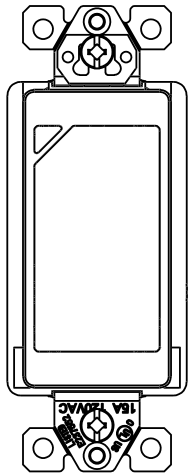

15A Decorator Full Guide Light



### WARNING

**Turn the POWER OFF at the circuit breaker before installing the switch.**

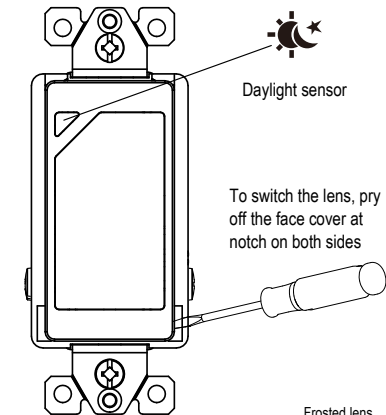
Read and understand these instructions before installing. This device is intended for installation in accordance with the National Electric Code and local regulations. It is recommended that a qualified electrician performs this installation. Make sure to turn off the circuit breaker or fuse(s) and make sure power is off before wiring the device.

Use copper wire only.

### WIRING DIRECTIONS

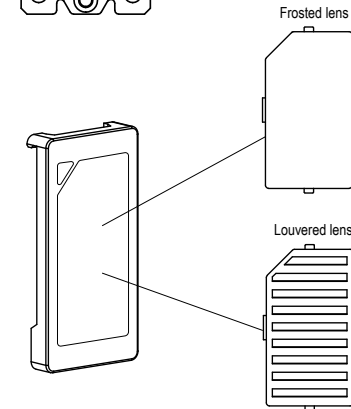
Turn off the power at the circuit breaker. Identify the HOT, NEUTRAL, and GROUND wires in the wall box. Insert wires into the terminal holes on the back side of the receptacle, then tighten the terminal screws to clamp wires in place.

- Insert the BLACK (LINE) wire into HOT terminal
- Insert both the WHITE wires into the NEUTRAL terminal (With silver screw)
- Clamp the two GREEN/BARE (COPPER) wires together, then insert one ground wire into the GR terminal (Green screw)

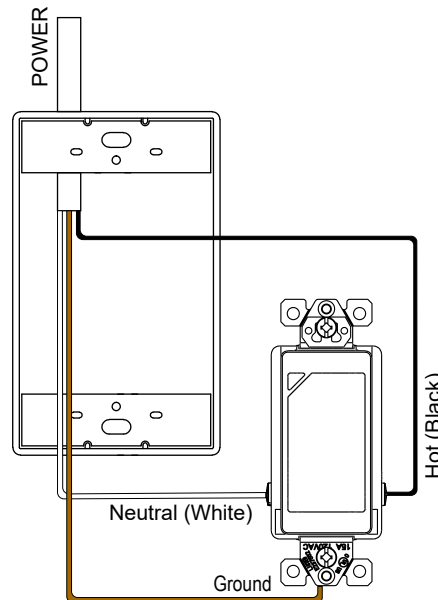
