

The 58300-3K is an add-on switch allows for multi-location dimming (requires 58300) to control a single Load.


OPERATIONS

Manual Control

This add-on dimmer switch allows the user to:

Turn ON/OFF and control the brightness level of the connected LED lighting.

- To turn ON the connected lighting: press top of the add-on dimmer switch paddle and release.
- To brighten the connected lighting: press and hold the top of the add-on dimmer switch paddle, release when desired level is achieved.
- To turn OFF the connected lighting: press bottom of the ad-on dimmer switch paddle and release.
- To dim the connected lighting: press and hold the bottom of the add-on dimmer switch paddle, release when desired level is achieved.

Turn the POWER OFF at the circuit breaker before installing the Dimmer

Read and understand these instructions before installing. This device is intended for installation in accordance with the National Electric Code and local regulations. It is recommended that a qualified electrician performs this installation.



WIRING DIRECTIONS

3-Way Wiring with 58300 dimmer

- FÈ Connect the HOT wire to the Hot terminal on the åã { ^\'.\Aswitch.
- CE Connect the NEUTRAL wire to the Neutral terminal (1) A & white.
- HÈ Connect the VÜŒXÒŠÒÜÁŒwire to theÁ/¦æe^|^¦ terminal on theÁHS switch.
- IÈ Connect c@Á/ÜŒXÒŠÒÜÁÓÁGÁG@Á\¢ã;œã;Áã;æåÁã^ÆV;æç^\\;ÁÓÆgÁ;Æš;æåÈ

- ÏÈ Mount the dimmer and 3K to the box with "Top" indicator pointing up.
